Consistent with the budget, ASOR is projected to break even or generate a modest increase in unrestricted assets available for operations (unrestricted net income) in FY 2016.

The Treasurer noted that the FY 2016 Budget calls for \$80,000 of Annual Fund contributions. However, to date, ASOR has only received \$40,000; we must receive at least \$64,000 before June 30, 2016 to make budget or adjustments will have to be made in other areas. The Treasurer encouraged the Board to step up to the plate
